

Our first year named Coverdale Justice Society proved to be another inspiring year of advocacy and impact for Coverdale. Continuing to advance our mission of improving access and alternatives to traditional justice while building on the Coverdale legacy has bred unprecedented growth for the organization through additional projects and expansion of existing programs. All of this while navigating the present day realities of a province wide housing crisis, exponential increases to cost of living, and continued navigation of the post pandemic era. I admire the entirety of the Coverdale community for all that you do.

Additionally, this marked my first year as the Chair of the Coverdale Justice Society Board of Directors. I am grateful for the opportunity to work with you all in this capacity. I joined the board in 2019 arriving just prior to the pandemic. With only a handful of in-person board meetings under my belt, along with the rest of the world, we adjusted to a new state of affairs. Regular board meetings were now virtual, masks became the norm, and navigating the impacts of isolation continued to unfold. Through our continued relationships with AHANS, DCS and Northpine Foundation, Coverdale secured. renovated. staffed. and began operations at Honour House. This permanent supportive housing initiative mirrors our efforts at Caitlin's Place by providing housing and support to young women and gender diverse folks on their journey away from homelessness.

This summary cannot completely convey all of the time, energy, effort that went into organizing and lifting this project to reach community members in need. Not only the sense of home but the comprehensive support and services provided.

With all of this growth in services provided by Coverdale, we've paralleled building our internal organizational structure. The roll out of updated personnel policies including our Workplace Violence Prevention Plan. important an accomplishment in our dedication to a safe and healthy organizational culture. This important work will continue as our programs and services strive to address community identified needs.

This year we welcomed new board members, Allison and Nami. I'd like to express my sincere gratitude for the dedication of all our board members, new, continuing and past, who are truly a joy to know and work with. I look forward to continuing on this journey with you all.

Dear Supporters and Friends,

As we reflect on the past year at Coverdale Justice Society, we reaffirm our unwavering commitment to serving equity-deserving groups in our province. Our mission remains deeply rooted in addressing the systemic inequalities that women, girls and gender diverse people face within, and outside of, the criminal justice system. We continue to pay special attention to the over-representation of Indigenous, African NS and 2SLGBTQ+ peoples in state systems, a result of the enduring impacts of colonization, slavery, systemic racism, discrimination and colonialism.

This year, we have intensified our focus on housing justice, recognizing that stable and affordable housing with appropriate supports is a fundamental prerequisite for addressing broader barriers. Our work at Caitlan's Place continues to be a beacon of innovation and success, demonstrating effective housing-first principles. We are proud that this model is now being adopted by various organizations across the country, expanding its reach and impact.

On December 1st, we proudly opened the doors at 1101 Wellington Street, where Honour House began serving young women aged 18-24 who are experiencing homelessness and are involved or at risk of interaction with the justice system. Honour House embodies our commitment to providing safe, supportive housing as a crucial step towards empowerment and stability for these young women and gender diverse folks. Our justice outreach program has been instrumental in bridging the gap between court requirements and the complex realities our clients face. By meeting individuals where they are—whether in shelters, encampments, or other precarious situations—we ensure that they can attend to their legal obligations, thereby preventing further escalation of their challenges.

We are also deeply engaged in addressing genderbased violence through our Safe Outside the System (SOS) project. This initiative focuses on anti-violence and domestic violence within 2SLGBTQ+ communities, inspired by the impactful work of the Audre Lorde Project.

Our dedication to supporting the reintegration of individuals into the community remains a cornerstone of our work. We believe in restorative communities, and the potential for every individual to rebuild their lives with dignity and support.

None of this would be possible without our remarkable team. Our diverse leadership is wholeheartedly committed to this cause, and our frontline employees our true heroes—show up every day, facing incredibly challenging work with unwavering dedication. Their resilience and passion are the driving forces behind our success.

The journey towards justice is long and often arduous, but together, we are making tangible strides. We thank you, our supporters and partners, for your continued belief in and support of our mission. With your help, we will continue to push boundaries, challenge systemic injustices, and create lasting change.

FINANCIAL HIGHLIGHTS

For the year ended December 31, 2023, Coverdale Justice Society recorded total revenues of \$1,667,199, marking an increase from \$1,436,116 in 2022. This growth is largely attributed to increased support from the Department of Community Services, which contributed \$928,732, up from \$695,462 in the previous year. Grants received were slightly lower at \$560.850 compared to \$587.023 in 2022. Additional sources of revenue included the Federal Justice Youth Program, Affordable Housing of Nova Scotia Funding, donations, fundraising income, and interest and investment income, all of which collectively supported our programs and operations.


Our expenditures for the year also rose, totaling \$1,667,199, compared to \$1,436,116 in 2022. The largest portion of these expenses was attributed to Caitlan's Place, which accounted for \$855,278, reflecting our continued commitment to housing justice and the expansion of this model. Salaries and wages were \$305,449, a slight decrease from the previous year, indicating effective management of our staffing costs.

In December, we opened Honour House at 1101 Wellington Street, incurring expenditures of \$260,135 to establish this new initiative for young women aged 18-24 experiencing homelessness. Other significant expenses included supplies and program expenses, office costs, rental expenses, training, professional fees, travel, telephone, and emergency crisis shelter expenditures.
